November Notes:

Approved with changes. For the pins, the seed money is \$725 for 500 pins. Action Item: Michael Nicosia will make sure the updated notes, along with the vicar notes, will get posted to our regional website via Bill Hanzel.

Treasury Report:

Notice, paid \$725 toward ECC pins. Each community has 100 pins to try to distribute. Let us distribute them face-to-face for recommended \$5 donation each. Yet to be determined how much we will distribute them for if we need to ship them. Money received should be returned back to Rocky Mountain Regional Council. Any money over \$725 will be donated to the

National ECC. A request for addresses resulted in what is on the ECC website. We are considering sending one pin to each ECC community. The pins cost \$1.45 each.

Also, decided to leave reports as a monthly report. At the end of the year, we would like to see a yearly summary by month.

SE Corner of Colfax and Wadsworth. Join the League of Women Voters at a vigil on the steps of the Capitol; Gather on Lincoln Street Sidewalk in front of Capitol

Michael is a speaker at Sandy Hook Memorial Soul Shop Workshop (regarding pastoral care regarding all affected by suicide) to be offered,

60-90 minutes, talk to Michael to set this up.

Local Bishop Process:

Much discussion and discernment. A general consensus that we keep the workings of the Regional Council, adding a bishop (to be proposed).

Decision, that the question of 67.4 is affirmed via the regional vote. Therefore, we have an Episcopal Vacancy.

Purpose of the February Regional Gathering is to leave with an understanding of where we are, and our next steps. To offer anyone the opportunity to join a team in developing of how we move forward.

Mid-America (no calls returned)

Pacific Northwest (summary from Bishop Kedda)

First a Suffragan – Bishop Tom Altepeter

Bishop Tom resigned.

A year of grieving.

Called a bishop to vocation: nominations, credentials and visits, vote, affirmation: Bishop Kedda Keough

Living as a diocese for a year before writing a constitution.

Regional council forming, and developing a constitution.

Florida: Letter of intention was read.

SouthWest: Doing the reverse of PNW; first developing a constitution, then calling a bishop. California: Jim Farris (not responded), developed organically around Peter Hickman.

Our Outline for January/February (March) Meeting:

- 1. After the Vote, this is what we know: We have an Episcopal Vacancy. Reference 67. 4 and the language of the ballot. Note the checkpoint built in with the Leadership Council.
- 2. Strength of the Rocky Mountain Region. Especially focus on the Regional Council. Our communication. Our collaboration. Our independence within our support of one another.
- 3. We have a polity, though not written down formally. Reference the Regional Council Mission, etc.
- 4. We don't have a local bishop. Reference this role as vocation. Use shepherding language. Refer specifically to these 5 ministries: sing of our local unity, clergy care, sacrament/ordination presence, episcopal council, face of the region to those outside of us.
- 5. Two independent parallel "path/chapter/process/journey-s" to move forward. People can join either path/chapter/process/journey. The two moving in parallel must also be in communication with one another.
 - A. Written polity/constitution for the Rocky Mountain REGION.
 - B. Episcopal Vacancy
- 6. Questions to discussion. (To be developed)

Let's have an expansion of this outline and created by December 20th, so that everyone can review and be prepared by our next RMR meeting on January 3rd. Team to do this work is Kae and Teri, with input as possible from Mike Weil and Dennis.

In addition, Jack will send everyone a draft of a local constitution that he constructed as a lawyer with talking point from the regional council mission statement document.

Initiating **Faithful Tuesdays** at the state legislature, a collaboration of CO Council of Churches, City Unite, CO Catholic Conference, Greater Metro Denver Ministerial Alliance, Interfaith Alliance of CO,

Mile High Ministries and Together CO; hosting multi-faith events and press conferences promoting a faith narrative that supports a just economy, works toward equity, and eradicates racism in Colorado. CCC would particularly address Homelessness and Death Penalty Abolition, et al. ED hopes to have Gov-elect Polis reinstate Governor's Clergy Council active in Hickenlooper Administration.

Published CCC End-of-year Appeal in The Journey Shared.

BISHOPS/VICARS CALL 11-14-18 Late on call; +Denise relayed following highlights:

Open Vicar positions filled:

East Coast – Fr. Henry Pruski; I will partner with him until he's up to speed. Southwest Region – Rev. Delores Krupp, partnered with +Kedda.

Constitutions across the ECC—+Francis notes that there is a trend focusing on building relationships within/as local church; not necessary to codify roles and policies ahead of time. Agrees with **RMR** voiced intention to articulate the soul/identity/mission of the region as first step.

PNW— Constitution on hold; will be basing it on their lived experience of being church together.

SW—appointed a Constitution Commission to develop one, 5 yrs in process already. **CA**—first formed around +Peter; Constitution codified by lawyer Rev. Janine Stock with no input or collaboration (AZ split off from CA diocese because of it) and is under reevaluation. CA just recently held their first Diocesan Council mtg.
