# Rocky Mountain Region of the Ecumenical Catholic Communion Board of Directors Meeting Notes July 6, 2023

## **Opening Prayer/Regional Prayer**

Holy One, Enlivening Spirit, In the wilderness of new, Root the Body of Christ Fully into our "Yes", Blooming in Your Holy Season. Together, Amen!

#### **Regular Business:**

- 1. Welcome to Joan
- 2. Agenda approvals/additions
  - July agenda approved by consensus with addition of a report by Joan

#### Deacon Joan Crawford

Joan reported that Bishop Frank asked her to put together an anti-racism statement, and that led to the Truth and Reconciliation Commission. She reported that there were two opportunities coming up that the Commission was promoting to bring further understanding to their work, which was currently focusing on the issue of the book banning laws being considered, and in some instances passed, by various states:

"Freedom to Learn Summer School July 13 -15; and

"Defending the Freedom to Learn" CRT summer School July 30 - August 3rd.

Discussion followed, and Joan said she would forward details on how to register for these/

- 3. Review and approval of June minutes
  - Ann said she sent the June minutes just prior to meeting.
  - June minutes approved by consensus.
- 4. Financial Report

- Chuck called attention to the June Financial Report that Greg Yonker had recently sent out. It was noted that expenses exceeded income by a considerable amount, but it was recognized that some communities made their payments quarterly.
  - The June Financial Report was accepted by consensus.

## 5. Bishop Notes (see Appendix A)

- Kae called attention to her Notes and asked for comments
- Discussion followed concerning how to make the various communities accountable for required reporting, payments, etc. through the RMRC, to support Kae, and discussion followed concerning the calendar of issues and accompanying diagram in Kae's report, both requiring that each community's delegates would be accountable for reporting their community's action on the items at monthly meetings.
- Following discussion, it was consensus that the RMRC delegates would share Kae's diagram with their Parish Councils to get commitment to the plan. Then a timely agenda item would be added to RMRC agendas and each community's PC agenda noting the deadlines for actions needed by their next meeting
- Kae asked that an agenda item be added to the August RMRC agenda for members to bring any accountability deadlines that should be added to her list.

## 6. Vicar Report (see Appendix B)

- Michael called attention to his report.

- **ACTION ITEM:** The members of each community need to register individually on the Regional Website in order to be able to access all information on the website.

#### 7. Leadership Council Report

- Chuck reported on a conversation he had with Teri Harroun about the 2024 Synod. to be held at YMCA of the Rockies in Estes Park. Teri appreciated the willingness of council members to assist, but said we should "cool our jets", as no activity or need for assistance was anticipated prior to October due to Leadership meeting schedules and results of grant requests due near then.
- 8. Personal Connections Chuck asked that we share what new activities we found for when the sun does not shine.

#### **Old Business:**

- 1. Regional Synod
  - Tom reported that the "Post-Its" on the wall had been transcribed, and that he would forward them to the group.
- 2. Financial Issues:
  - a. Dennis reported on the information he had been able to gather.
- Following discussion, it was consensus that \$12,000 be placed in a non-penalty Certificate of Deposit with CIT, and Don said he would contact Greg to get this done.
  - b. Kae's employment status in the Region.

- Following discussion, and upon motion duly made, seconded and unanimously carried, it was **RESOLVED**, that despite language that might appear to be contrary in Bishop Kae Madden's Call, the Region's Constitution or Bylaws, it is agreed that Bishop Kae Madden is an independent contractor for compensation and tax purposes.
- Discussion then followed concerning whether or how to amend any of the above documents to clarify the Regional Bishop's status for all matters relating to employment. It was consensus that an ad hoc committee to consist of Dennis Goblin, Chuck Howard, Kae Madden and Jack Wolfe be formed to report back on this subject to a future board meeting.

#### 3. Collaboration with Colorado Public Radio

- Chuck reported on has communications with CPR, and called attention to the information that they responded with, which he had sent out in an e-mail to the group.
- He suggested that this matter be set aside until the "accountability" work be completed and the region had decided on its "core values."
  - Jack suggested reaching out to radio stations in Boulder and Fort Collins.

#### 4. Pridefest 2024

- Michael suggested that a committee be set up sometime after February, in time to meet the June deadlines with a representative from each participating community, but not necessarily an RMRC delegate.
- 5. 2024 Synod planning see above
- 6. Update on Greg Y's status as a director Matter resolved at June meeting.

## 7. Community Feedback on Beautiful Redemption Initiative

- Alice, Rosean and Chuck reported on their communities discussions and decisions. Holy Family and St. Paul have not had an opportunity to discuss yet.

St. Paul: StP had a Denver City Council person come to speak on LGBTQ issues.

**COB:** Dennis reported that Deacon Buddy had "unretired."

January: Code of Ethics and Safe Church reporting. Even years: ECC synod delegates determined. Initiate delegate meetings.


