It was brought to the Council of Bishops and encourage writing a statement outlining the foundation of our validity, perhaps addressing it during +Francis' state of the communion address at synod. Pending.

Council of Bishops

- Council of bishop calls on Aug 8, 17th, and 30th Lots of email communications.
- Leadership Council suggested that having a 2nd bishop present for LC meetings may be helpful. The Presiding Bishop appointed Kedda to serve consistently as a "guest" (no constitutional amendment required) primarily to assist with communication and accountability.
- Council of Bishops bylaws completed.
- The Southwest region is waiting on a vote regarding proceeding to form a diocese. Vote due Sept 1.
- Response to HOL guidelines presented to us for new faith communities
- Mid America Diocese: Rafe is retiring, and the MidAmerica diocese will likely not hold an election prior to synod.
- Follow-up on St. Matthew's: Ongoing

Statement on Petition from St. Matthew from Presiding Bishop Francis Krebs

St. Matthew ECC Community in Orange, CA, has recently made a petition to the Communion to be its own diocese. Article V, Section 8 of the ECC Constitution states that all applications

for the formation of a new diocese must be reviewed and affirmed by the Council of Bishops. We take our responsibility, to which we have been called by the Communion, very seriously. We will entertain this application from the Community of St. Matthew in a manner commensurate with our obligation to uphold the Constitution and Statutes of ECC. And we will find a way to live up to our highest standards. Processing this application may not happen as fast as some may like. We bishops have a responsibility to get this right because of the precedent that our decision will set. That is what we intend to do. We ask for your prayer as we endeavor to walk that path.
