#### **OLD BUSINESS**

1. Update and Planning for October 11-14, 2024 Holy Synod at YMCA of the Rockies.

- Chuck said that with the resolution of the mid-America challenges, new info should be coming forward in two weeks;
- Info will be sent to the whole ECC in a whole ECC newsletter; please make sure our members are informed.
- Kae wonders if we have extra funds if some might be reserved for scholarships for delegates to Synod- perhaps from the renewal of the CD
- First meeting of RMR delegates to the Synod is at 10 am on Feb 17.

# 2. Feedback on January 18-25 Week of Prayer for Christian Unity.

Mother Roseanne said it was wonderful and the participant from Trinity Lutheran was especially pleased. Tom Moos and Laurie Gudim did a great job with AV and ensuring that speakers were heard and unmuted for their parts.

Chuck Howard said the pastor from the Lutheran church was also very grateful.

How many participated? Tom reported 28 individual ZOOM sessions with multiple participants at some sites, so maybe 40 attendees in all.

Kae's ecumenical participants also liked it. Because of the ECC issues it was especially poignant. Jane R said it was beautiful.

#### **REGULAR BUSINESS**

# 1. Accountability calendar.

Michael wants the calendar to include participation in the Marade. CSU and Ft Collins also have an annual march and MLK celebration. In December calendar we should start planning local celebrations with partners. Jane noted that Holy Family does not have a nesting partner now. No participation with any other groups now. Michael says in the past Holy Family partnered with Our Savior's Lutheran, e.g., Family Promise.

# 2. Financial Report Greg Yonker

Greg Yonker requested that we update our records of his email address (gyonker@me.com) and his mailing address for sending tithes and other physical mail is 11951 Ridgeview Lane, Parker, CO 80138. More income over expenses in January.

## 3. Bishops Report

Boundaries and Ethics participants from ECC outnumber the ELCA members; the course is more than just boundaries and is well done and an expansion of the more traditional boundary training. Rev Alice finds the course robust and thought provoking.

St Louis communities remain in the ECC and with the Emmaus community will now be under the proto diocese; St Benedict also remains (Question: does this refer to the Benedictines of Holy Wisdom? I thought they are national, not necessarily Mid-America?). Future of the mid-America diocese is under discussion.

#### 4. Vicar's Report

Website has new photos of people and recordings of the Prayer for Christian Unity Service and the edited ECC 101 Webinar. Too early for formal planning for Pride. Adrian Miller is going to be inducted in the Colorado Black Hall of Fame. Michael is registered for the World Council symposium of the Council of Nicaea.

#### 5. CD re-investment

Greg mentioned that he plans to rollover the \$14K CD when it matures. Bishop Kae thinks we should only re-invest \$10,000 when we renew and reserve the remainder for potential synod expenses. Greg thinks we should do otherwise. Greg thought we had enough funds in our accounts, outside the CD, to offer some Synod scholarship support but as discussion progressed, the potential outlay might be more than anticipated – especially if we offer some scholarship support for Spanish-speaking communities in CA. Ultimately, he agreed with Kae's proposal.) The best estimate is about \$3000 per community for 4 delegates.

Our current monthly expenses are about \$609. Per month. We have about additional \$3,000. With the CD and bank balance, the total is \$21,000.

**DECISION:** Move \$10,000 into a new CD and put the difference into our bank account. Bishop Kae moved and Greg seconded. Unanimous vote.

Bishop Kae reminded us that public radio might be a good venue for us to advertise.

Kae and Dennis agreed to serve as the scholarship committee.

A discussion about how wide to offer scholarships – e.g. the California diocese and how to determine scholarships to individuals.

This is a unique year because we do not have travel expenses for our local delegates.

Each community will assess local needs and discuss and feed the info to the scholarship committee and to Greg so he knows the extent of the need.

The item will be added to the agenda for the next meeting.

The Council agreed to this proposal for fielding scholarship requests.

#### 6. Leadership Council Report Covered earlier.

Michael needs response to the proposal for a retired clergy association.

#### **NEW BUSINESS**

## 1.Regional Marketing Plan Alice Bradley

Wondering how much we should do regionally as other groups (specifically LOC) have used professional marketing persons. She summarized conversations with Teri Harroun who said it was a detailed process, got a lot of info and education and outcomes for the community. She will come and talk about the process and how it might be utilized in the region.

Could we use the COVID grant money for this purpose? It seems a bigger issue than COB. It would benefit the whole region. Chuck thinks what was learned would be extremely useful for a wider ECC audience. At a transition point between phase one and phase two. Alice and Teri will discuss what can be shared.

Michael said he could really use the marketing consultant's expertise on SEOs (Search Engine Optimization) for the website. Would take him scores of hours to add them to each page, entry and photo.

Jane reminded us that that Bishop Pablo had requested a publication plan, four of us volunteered: Christine Casillas, Mother Rosean, Jane, and Fr. Len.

Subsequently, Christine moved to Las Cruces and no longer ECC, Mother Rosean was no longer able to attend.

Fr. Len and Jane declined to continue because the work could not be done by two people.

Nonetheless, it remains important that we have a messaging platforms and schedule, which can be part of a marketing plan.

Don voiced how important it is that we have someone who is objective create the messaging and platforms because we are too subjective to come up with what a non-ECC informed reader wants to know.

A lively discussion ensued - detailed about how best to utilize what has already been learned and how it can be shared and whether the consultant might best be engaged at a broader level. Alice is concerned about using what someone else commissioned and paid for. Chuck will learn the details and see what can be shared and how we might best collaborate.

Maybe we should create a committee to meet with Aaron and see where this goes. Michael especially likes Aaron doing the implementation since it is so time consuming. Chuck says Aaron had flexibility.

How best move forward? Liz asks Chuck... he would prefer people who are detail oriented so all facets and aspects are considered.

Alice: should we invited Aaron and Teri to this Council to discuss and explain.

Messaging and Marketing are included but different?

Liz thinks we should move on this, especially if we wish to use CPR. Chuck says they needed to develop messaging first their focus ended being on website.

Alice will work on scheduling. Group feels worthwhile to move process forward These Minutes can be a resource for the meetings.

#### 2. Financial commitment to the region

Send regional tithe commitment to the region (Greg) and the national within the next two weeks, based on income and projection. Also the Colorado Council of Churches: \$1 per person and \$60 vicar donation per church.

#### 3. Clergy continuing education

Kae- what has been decided in the past? Constitution/ by laws.... Michael recovered the draft document from ECC on continuing education- it calls for 10 hours per year

Uncertain about what constituted what was education? No book reading, must be interactive... Boundary training counts.

Continuing discernment with candidates Mike and Christy. Conversations continue with another presbyterate candidate.


