- Weighty issues related to policy consensus still the goal, but we can talk about having the buck stop at Kae if need be
  - Can be voice of dissent, but still want to work through consensus
- o Fr. Don
  - Negative experience with the former host church was made better by Kae's support, a different form of support from the community. Kae's presence was important for meeting with Bishop Gonia.
- Dennis
  - We don't know yet what this relationship will be, but will continue to develop over time as we grow as a region
- o Fr. Don
  - Annual informal celebration of regional relationship (no business, only party)
     e.g., LOC annual meeting a good opportunity for business;
     e.g., LOC St. Pat's day a good opportunity for party
- o Tom
  - Important to keep hearing regional stories and build connection in order to continue being ecumenical

### 4. Bishop's Call Agreement draft initial discussion

- Starting point is ministry description
- Call letter should be specific to bishop, with a list of responsibilities, allowing option for delegation - make as open as possible for those with different strengths to make bishop's office work for future candidates
- Needs to have nuts and bolts information like a job contract
- Accountability for both council and bishop
- Compensation should be listed in this document need to specify independent contractor vs. employee
  - Bumps up from independent contractor to employee if council dictates how to do job, not just what should be done in eyes of the state
  - o Difficult to do housing stipend (similar to Fr. Michael) for Kae's situation
- Other financial obligations regarding synod travel costs, for example
  - o COB split with regional council?
- Use feedback/listening sessions with Kae as a baseline for call agreement
- Call agreement not needed for 501 (c) (3) filing
- Action: start with broad/vague agreement, but Kae will ask about it at the next Bishops meeting to see what others are doing (including Bp. Frank). Alice and Greg to work on draft.

## 5. Approve minutes of October 7th Meeting

- Change control enabled minutes approved.
- 6. Financial Report including status of temporary budget and decision on Fed loan payoff
  - Office space originally \$200/mo, no agreement, but may want to go down to \$100/mo based on usage
    - Want to maintain relationship for when things open up again, but it's not being used right now
    - Action: discuss ways to structure agreement to be more usage-based
  - Laptop not needed
  - Action: no excessive expenses predicted, so loan can be paid off now (approved by consensus)

    - o Church vandalism issue hasn't had any movement
      - Action: publish on RMRC social media, edit to be blanket condemnation
    - o Thank you to Michael for inclusion of testimony regarding affordable housing in Aurora
  - Bp. Kae
    - Chrism Mass traditionally held during Holy Week, but it doesn't need to be
      - Proposal to move to summer to pair with outdoor celebration approved by consensus
      - Action: communities check to make sure they have enough oils to make it until next summer
    - If asking Kae to preside somewhere else, give as much heads up as possible to arrange for quest presider at COB
      - Host community would give quest presider stipend to COB for their substitute
    - Development of regional website could include pages for each of the communities, adding cohesion
      - Use grant money to budget for this?

**Participated in Together Colorado's** race and class narrative workshop on Oct. 21: Amended our COB blurb on Prop 120 as follows: *FYI: Colorado ballots: PROPOSITION 120* 

We need taxes to support services that matter to all of us: all colors, all income levels, all people of faith. Across the state, at all altitudes, we treasure good schools and education for our children and grandchildren. We count on fire and police protection to be safe. Isn't it great to have a world of knowledge at our fingertips in free public libraries? Enjoying the wide outdoors with public parks, open space and playgrounds brings joy and peace, enhancing our well-being. This proposed tax reduction will further decrease support for essential services that we and our neighbors need and use. Who benefits from the proposition? Only the few who own hotels and lodging properties. This proposed reduction in property tax is limited to a small commercial group, not homeowners. Colorado Council of Churches Board (of which we are a member) and Together Colorado voted to oppose this initiative because of its negative impact on the common good. ## Appendix B—Ecumenical Engagement Report (Fr. Michael)

#### **KEY POINTS and ACTION ITEMS**

REGIONAL WEBSITE PLANNING—not started as no one has come forward to assist yet.

#### STATEMENT ON CHURCH VANDALISM

- Some resistance from CCC Judicators fearing perception of being self-serving (we signed letters of support for mosques and synagogues but have never initiated one; may lead to reframing the statement or publishing at a later date to separate it from the recent actions against Christian churches.
- Feedback from our Regional Council includes desire to publish if CCC doesn't; sooner the better.
- Submitted revised draft for consideration:

As members of the Colorado Council of Churches, we decry the recent acts of vandalism against the sacred spaces of our Roman Catholic siblings in Christ. We regret not having initiated formal condemnations of previous desecrations of any sacred space of any faith tradition. Our delayed response to the vandalism at the Cathedral Basilica of the Immaculate Conception on October 10th was due to a conscious effort to address an issue deeper than anti-religious bias.

While acts of violence are sometimes committed in response to perceived injustices, we do not condone vandalism, hate speech, the desecration of sacred spaces, or any form of violence as an expression of public dissent. We encourage open and honest dialogue around contentious issues, especially in these times of polarization within church and society, that we may together build a Beloved Community that addresses the needs and concerns of all.

# **Appendix C—Aurora Housing Project Testimony**

Presented on October 25, 2021 to Aurora City Council, and published widely by CCC.

My name is Fr. Michael Nicosia, a member of the Board of Directors of the Colorado Council of Churches, and a resident of Aurora.

Thank you, Mayor Coffman and esteemed Council Members for the opportunity to speak in support of Mountain View United Church R-2 Zoning. The 14 member denominations of the Colorado Council of Churches support such initiatives and applaud congregations like Mountain View for seeking to provide affordable housing to some of Aurora's citizens.

One of the painful realities in our society is that wages have not increased enough to keep up with the cost of living. Back in 2012 I began working full-time for a local hospice, making

less than \$35,000 annually; over the course of my 3-year chaplaincy I didn't receive a single cost of living increase.

To this day, wages have remained stagnant while housing prices have continued to increase. Sadly, this is a reality faced by many essential workers.

At present one in three households in Aurora are cost-burdened.

I'm now nearing retirement age—working for the church, though, I'm not sure when I'll be able to do so! Regardless, if my husband were to become unable to work or should die before me, I might not be able to keep up with the mortgage payments.

With housing prices being so inflated in recent years, if I needed to sell, my finding affordable housing on a limited income would be a struggle, if not an impossibility.

It has been mentioned that under 80 properties are for sale in Aurora for under \$300,000, but keep in mind—the demand is so great that paying \$100,000 over the asking price is not unheard of.

The city's comprehensive housing plans specifically call out the need to create more housing that might be affordable for our city's workforce earning under \$80,000 a year.

While I admit that even that threshold would be out of reach for many, the Mountain View project and others like it would be an invaluable good start.

True, the number of homes proposed may warrant some adjustments on the part of the surrounding neighborhood, but my hope is that we can embrace sacrifices made for the common good.

I and my colleagues of the Colorado Council of Churches support this project. We respectfully request your affirmative vote on the proposed Site Plan and re-zoning application. Thank you for considering this matter as it impacts the well-being of our citizens and ultimately of our entire City.

Site plan approved. Also working on testimony for second hearing on re-zoning scheduled for Nov. 8. I hope to make the point "if not here, where?" and if we're really going to live up to our commitments to affordable housing many more neighborhoods should be rezoned; also will focus on need for city regulations that can mitigate impact of higher-density populations, e.g., reduced speed limits, enforcement of state statutes and city ordinances regulating unnecessary noise, expansion of public transportation accessibility, et al.
