#### ROCKY MOUNTAIN REGIONAL COUNCIL MEETING Notes - May 3, 2018

- 1. Opening Prayer: Kae
- 2. Agenda Approval: ok Fr. Scott will not be present at this meeting
- 3. Approval of April Notes: ok
- 4. Financial Report: The 3% vicar stipend increase has been implemented.

  Mary of Magdala will send in one check for their annual pledge in June and then make any adjustments in December. Light of Christ sent some payments that are not reflected in the financial report and have not been cashed, so Teri will follow up with Lara.
- 5. Vicar's Report: Attached at conclusion of notes as Appendix Hope to establish a Deacons Association including new candidates following Synod. Re: St. Paul on June 2<sup>nd</sup> – Catholic/Lutheran shared Eucharist – Book recommended by +Francis Declaration on the Way: Church, Ministry, and Eucharist that highlights communities. Len recommends a Presence book that has a focus on Ecumenical identity and Catholic identity.

# **NEW BUSINESS**

6. Local Bishop

Following discussion that included the need to be both bold and clear, the fact that many parish members have probably not read the constitution that implies growth into "dioceses," the consideration that a parish may not want to go forward with calling a local bishop and threaten leaving the ECC, and that the process could emphasize the synodal process that leads up to a slate of candidates, it was agreed that the preliminary ballot question is: I support moving forward with the process of calling a local bishop in 2019.

Here is a summary of the discussion regarding what we are taking to our leadership councils this month:

First, what constitutes affirmation? Two-thirds of the members voting in affirmation in a community is a community in favor. If four out of five of our communities affirm, we would move forward. Each community needs to discuss the spirit of consensus – that our community would be willing to "live with" the decision of the four communities collectively.

Second, all communities offer all members an opportunity to vote on the weekend of Sept. 8-9, including providing a way for "remote" voting. Each community will engage in education preceding the

vote, offering both pros and cons, utilizing as a basis the common document prepared by the regional team.

Third, the ballot question: I **support** moving forward with the process to call a local bishop in 2019.

or I do not support moving forward with the process to call a local bishop in 2019.

Fourth, the "fine print" or covenant conditions, the foundation on which the votes stand (this language may or may not be on the ballot itself?)

The process of moving forward to call a local bishop will include the following agreements:

- Prayer: steeped in prayer, held in prayer, begin and middle and end in prayer
- The votes of each community will be received the same weekend, prior to synod, so that delegates may attend the synod with the region's clear direction.
- The process of calling a local bishop will be researched, developed and presented for affirmation by a regional group (TBD), synodal in composition, with lay and clergy representatives from each community as well as our vicar and +Francis or +Denise, the 3-legged stool in action.
- The history of forming "households or regions" across the ECC and the current movements will be studied.
- Nominations for or discussion of candidates is not permitted until the process is developed and affirmed.

It was further agreed that the region move forward community by community with prayer and education ending with the above question and a vote by Sept. 8 or 9 before Synod in the Fall. Action Item: Each community will address: Is 2/3's of 4/5's okay? Bring up any other issues that need to be cleared up before the June meeting regarding timeline/process. Identify any areas within our current materials that need clarification and send in advance of the June meeting so they can be resolved. Compensation of a local bishop needs clarification.

# **OLD BUSINESS**

- 7. A. Delegate Phone conferences regarding Constitution Revision: Kae recommended that the RMRC recognize the delegates' ability/responsibility to organize themselves and not have RMRC in the middle. Another call needs to be scheduled to address the final revisions: II and IX. Kae will initiate the next call if another delegate does not initiate – responses due before the end of May
  - B. Welcome to St. Paul, June 2<sup>nd</sup> at 5:00 p.m. with reception following. If +Denise is coming just for St. Paul, St. Paul has it covered as far as expense. If there is a clergy gathering or other region-wide "business" then perhaps the region can share in the expense.
  - C. No strong feelings either way regarding a Chrism Mass. Vicar Michael will send out a questionnaire to see if there is an interest in a clergy meeting while +Denise is here.

Recommendation for a gift for +Denise. Teri said she would shop for the gift though she will not be able to be present on June 2<sup>nd</sup>.

D. Rapid Response request tabled

E and F. Aux. Bishop compensation – A letter will be sent by Jack to members of the RMRC to be forwarded to the lay delegates in order to formally request that this be addressed in the HOL at Synod.

# **CCC** April 25, 2018 CCC Board Meeting

- Joining Common Cause, the Board approved CCC support for **Colorado redistricting measures** through independent citizen commissions (pdf Common Cause redistricting)
- Support for Faith Leader **Letter to Abolish Constitutional Slavery** (pdf), particularly hoping to curtain abuses of for-profit prisons.
- Agreed to invite rep of **Colorado Faith Communities United** to End Gun Violence to offer a presentation to the Board; acknowledge all Judicators not on same page, so CCC can only be a conduit for information.
- Agreed to invite **A Little Help** to give a presentation to the Board on expanding services to homebound seniors; now in six counties, staffed by volunteers, financed through private grants and ind. philanthropy; challenged to develop teams in Aurora; hopefully state-wide in 7 years.
