REGULAR BUSINESS:

- 1. Update on Fr. Don and Fr. Michael's mother, Rosean and any general health concerns check-in
 - a. Don has new view of life after facing death. Rosean is doing better. Michael's mom is doing well. Kae's mom is slowing down some.
- 2. Financial Report:
 - a. Greg gave oral report.
 - i. Dues paid to CCC.
 - We have SBA Loan and Grant. Dennis mentioned using SBA loan for Bishop costs. Teri inclination to release SBA Loan back to help other people who were in more need. Greg not sure if that would happen. Don asked if we could funnel to someone else and let them pay the loan back.
 - iii. We should make financial decisions as a council

 - c. It is important for us to stress the importance of participating in the Census to our communities.

OLD BUSINESS:

- 1. Community updates (round robin): short term plans regarding liturgies.
 - a. COB meeting in Zoom for August and Beyond.
 - b. Michael presided in Dignity Denver. Just starting meeting in person socially distanced;10 people and zoom; all sort of precautions. Hand sanitizer used during liturgy. No sharing from cup. People received and then socially distanced to take off mask to take bread. Only drawback: you cannot see all the people.
 - c. St Paul will meet through August using zoom. Every week every one (of both traditions) worshiping together; daily prayer group. It has been great.
 - d. Mary of Magdala using zoom. Getting to know people this way. The three communities have had discussion about meeting outdoors. St Paul's and Trinity have done it. Last Sunday of July will be MOM attempt at outside. Jane's first Mass 7/26 at 11am with Communion pickup available afterwards.
 - e. LOC will continue Facebook live. Zoom Mass on Wednesday. On 18th of July try an outdoor meeting with Lutheran requirements.
 - f. Holy Family meeting by Zoom through August. Are having discussions about meeting outside. No formal plans yet.
- 2. Calling a Bishop:
 - a) Did the teams reconvene? Greg report.
 - Did not convene the teams. It was more important to focus on the national constitution feedback.
 - b) Polity does not see any conflicts between national and regional constitutions.
 - c) Timeline for what's next?
 - When we reconvene need to start with nominations. We need to reenergize the community around the issue. Come up with time line.
 - Bishop Call Committee does not have people from HF and MOM. Can we get members?
 - Consensus on moving forward conservatively. We have a nomination form and need to re-date the letter. Start with calendar and see how it goes.
- 3. Ordinations update?
 - a. Congratulations Jane on Ordination.
 - b. Alice is very close we will know in a few weeks hopefully.
 - c. Roseann has been delayed. She is scheduling her next class.
- 4. New National ECC Constitution and Statutes sent to Synod delegates. Have we talked to churches about choosing delegates and reading the constitution?

Bishop Francis vision and honesty is refreshing and compelling. But do not feel that light in the proposed Constitution.

It was good, but it was a little late.

The letter of invitation highlighted fund raising.

The fact that only one session was recorded was bothersome. Wish they had recorded all of them.
