Opening Prayer/Regional Prayer (Rosean began the meeting at 6:09)

Regular Business:

- 1. Welcome any guests: Gail Craun (Holy Family) attended by phone but, due to audio problems, could not be heard.
- 2. Agenda approvals/additions: No reorg, no additions. Rosean asked that folks email her at motherrosean@gmail.com, not roseanlaurie@gmail.com.
- October notes approved as distributed by Greg.
- 4. Financial Report
 - Kae shared Greg's financial report and Alice lead the group in reviewing. No questions or concerns and budget was approved as presented.
 - In the context of the financial report, we reviewed Bp Kae's Synod expense report. Tom moved, Jack seconded that the RMRC cover the \$891 in outstanding Synod expenses. Motion carried without objection.
- 5. Bishop Notes and Vicar Report Kae's Bishop Notes:
 - Kae summarized some impressions of the Catholic Bishop Forum focusing on building relationships among independent Catholic bishops. There was much discussion about the value of bishops, reflecting some of the RMR's conversation when calling a bishop. She also noted the challenges of one day being a cleric and the next day being "The Bishop". Episcopal and Lutheran churches have 3 years of school/training for how to be a bishop.
 - Kae also commented on the ECC Council of Bishops meeting after Synod:
 - Relationship building
 - Pablo's focus areas seem to be interfaith connections, work with the marginalized, continuing the Truth and Reconciliation efforts.
 - o COB may begin a symposium with a "book of the year"
 - o Desire for an ECC "youth day"
 - o Bp Tomasz invited people (esp bishops and youth) to Poland
 - o "Diocese" -vs- "region" discussions are ongoing.
 - o An immediate "TODO": form a hearing committee with membership from HOL, HOP and COB to review "Constitutionality" grievances and issues.

- Bishops are still in process of responding to St Matthew's request to be its own diocese.
- Bp Rafe is now officially retired.
- o Discussion on how to support new PB Pablo and transitions to Colorado.
- Next Synod in Colorado:
 - 1. Jack cautioned about Synod over a weekend (Bronco schedule)
 - 2. Jack encouraged some planning ahead to save \$\$\$ and vacation time before the next Synod to enable participation by more members of the ECC thereby allowing more people to share in the love and joy.
 - 3. To accommodate communities without a presider for weekend Mass during Synod, Michael suggested we open the ending liturgy to whomever wants to attend, whether delegates or not.

Vicar's report.

- Other communities outside the ECC might like to participate in the Advanced Care Planning. Michael is looking for suggestions for a central ECC site with good AV tech expertise particularly for Zoom.
- RMR webpage: Michael still needs to approach the web designers who bid the project to verify the contracted estimate hasn't changed.
- 6. Leadership Council Report
 - No one was able to provide an LC update. Questions were raised about when an evaluation form and recordings from the Synod general sessions might become available. Kae to pursue with Teri.
- 7. Personal Connections what surprised you in the month of October?

Old Business:

- 1. Update on website.
 - Nothing new to report. Michael continues to do some work pulling together materials from the RMR communities.
- 2. Regional Synod Planning for 2023
 - April 22/23 seems to be the preferred timeframe.
 - Kae asked us to suggest topics. Some ideas proposed:
 - O Where are we post-Pandemic?
 - Moving the OPB from St Louis to Denver
 - Shared prayer
 - o Begin brainstorming ideas for resolutions for the next National Synod
 - o Begin organizing a National Synod 2024 planning committee
 - Offer some kind of workshop (Jack suggested George von Stamwitz as a possible speaker)
 - What does it mean regionally to be a member of the ECC?
 - Kae raised again the idea of a Chrism Mass.
 - Brief tangential discussion on a Reception for Pablo but the group felt this should be separate and sooner than a regional Synod.
 - LOC and MoM suggested as venues for the Synod -- check facility availability.

Kae proposed meeting over zoom on Sat Nov 19th 10:00 – 11:30 to have an initial planning meeting and determine who might wish to participate in planning a regional Synod.

3. Future RMRC Meetings

- Most meetings will continue to be at 6:00 on Zoom, trying to finish in 90 mins.
- First Saturday in May and October proposed for meeting in person, 10:00 noon. No objections.

New Business:

- 1. Safe Environment Training: Who is doing what?
 - MoM using the Episcopal Church's training along with sister communities St Paul's and Trinity Lutheran. This seems to be one of the options recommended by the SEFFY+ team
 - LOC Jack and Chuck will investigate and report back.
 - SP has a Council member who has years of experience providing this training. Question remains open whether this would be an OPB-approved training.
 - COB has constructed their own training leveraging materials from certified courses. Alice also questioned whether this meets OPB approval/certification? Regionally, we seem to be ahead in requiring this training not only for clergy but also youth ministers.
- 2. Pablo's Reception: We agreed to ask Pablo about a reception before planning one. No decision on when/where.
- 3. Discussion of legislation/resolutions. We briefly discussed why the resolutions presented for 2022 Synod weren't offered for an acceptance vote, timeliness of the some of the issues (e.g. Ukraine resolution). Michael suggested we formally request George von Stamwitz to forward legislation/resolutions as they are received rather than sending everything out late as a package.

4. Community Updates:

- St Paul Michael has been busy setting up a website and has learned much that
 can be leveraged for setting up the RMR website. There are still some pieces
 missing but it is coming together well.
- MoM had an All Souls service on Nov 2 that was well attended (by 30+). Bp Kae will visit to do confirmation on Nov 6. Worship time is being moved from 5:00 pm to 12:30 pm beginning Nov 13.
- COB had an annual drive to collect mostly homemade hats/scarves/mittens for the unhoused. Had 2 services for All Souls (one in-person and another on Zoom).
- LOC: conducted a neighborhood outreach with Bethany Lutheran. The parish council has some new members but has also lost some institutional memory.
