 - Not much going on during December.
 - Mid-America diocese still working through issues.
- Vicar's report (see email report from Fr Michael dated 2 Jan 2024, Appendix B)
 - Photos needed for the regional website.
 - Moved founding documents to the general public section of the website; everyone can now see the constitution, by-laws, and values. RMRC minutes back to 2018 are also available to view.
 - Discussion on whether or not minutes should be public; agreed that confidential information is not included in the minutes. Finance report is no longer included in the minutes.
 - Discussion of Executive Council RMR BOD has a statutory right to convene an Executive Session, as needed session is not public.
 - Jack will follow up on rules/guidelines for an Executive Session.
 - Retired Clergy Association Michael is working with Scott Jenkins on establishing the RCA. Scott has contacts in the Episcopal Diocese. Some questions raised so far: For Episcopals, the mandatory retirement age is 72 for liability reasons does the ECC need to consider this? Clergy have faculties through the local bishop, so the RMR BOD could potentially be liable. What are the RMR/ECC policies?
 - Blessing will take place at the Colorado State Capitol on 12 January, 1030 1200.


